## Fighting to retain local Jobcentres

The Jobcentre Plus on Maryhill Road is earmarked for closure by the UK Government's Department for Work and Pensions. Those using Maryhill job centre would be directed to Springburn instead.

Concerns have been raised with me that this will lead to significant difficulties for vulnerable groups including the cost of travel,

considerably longer journey times (particularly significant for those with a caring responsibilities) and a far poorer service for supporting individuals back into employment.

Concerns that Springburn Job Centre is also not geared up to take the additional volume of business may also lead to a poorer service for those already using the

Often constituents contact me in relation to concerns over bus services. The most recent community to have a bus service withdrawn is Kelvindale, with First Glasgow's 4A no longer servicing the area.

Following my intervention, along with local councillors, a replacement service (the M4) is now being trialled for 6 months. I still don't believe this is the most appropriate service and I have therefore launched a parliamentary consultation on 'Connecting Kelvindale' with 4,000 households being contacted. I will use the analysed results to make further representations to First

Glasgow for service enhancements.

I intend conducting similar consultation exercises on public transport provision elsewhere across the constituency and I would be interested to hear the views of constituents.

Having made representations not just to bus companies, but also Strathclyde Partnership for Transport (SPT) I believe both need to perform far better.

I will therefore be keen to make representations to the Scottish Government's Transport Bill when it is presented to parliament. Its intent is to improve bus services.

Springburn Job Centre.

Underlying all this is very real worry from constituents over the ever greater risk of benefits sanctions.

I have met with Job Centre Plus, the trade union representatives PCS, and raised the matter in the Scottish Parliament with First Minister Nicola Sturgeon and Jamie Hepburn MSP, the Minister for Employability and Training - they share much of these concerns.

I have also sought and gained cross party support to have the matter debated in the Scottish Parliament.

The motion lodged is printed here and I intend making a powerful submission to the UK Government consultation on the matter objecting to the closure.

### New constituency office now open

I am pleased to announce my new constituency office is now open at Maryhill Burgh Halls.

It is a well-established landmark, built in 1878 and refurbished and re-opened in 2012, in part thanks to European funding and a £1.8m Scottish Government grant.

Co-located beside the Glasgow Life sports centre and down from the new Scottish Government funded £12.4m Health Centre in Maryhill, I was keen to open my office in a growing community hub.

## Boosting community regeneration

I have been working with Springburn Community Council to see if a co-ordinated plan for regeneration can be developed.

I updated them on the successful work being undertaken by the Royston Regeneration Forum on which I sit. That brings together housing associations, child care providers, schools and elected representatives amongst others.

Most importantly it seeks to place the voice of the local community front and centre. Ambitious plans are starting to emerge.

I am seeking to identify local partners in Springburn to form a similar forum for the local area. I am pleased that NG Homes are keen to be involved and I am determined that in the future the voice of the local community will be placed at the heart of any emerging plans.

I would be keen to support regeneration efforts in your area and would encourage constituents to get in touch.

## ScotRail meeting secured to develop improvement plan for local train services



The need for service improvements on our rail network are well documented. I met ScotRail to ask for community engagement with local commuters and for a local rail service improvement plan to be implemented.

ScotRail have agreed and I have secured a public meeting which ScotRail will attend at

7.30pm on Wednesday 1st February, at Ledgowan Tenants Hall, Shiskine Drive, Summerston. I hope as many rail users as possible will be able to attend.

I also took the opportunity to raise the matter during a recent ministerial statement on rail services. I asked Scotland's Transport Minister, Humza Yousaf MSP to take a personal interest in any future improvement plan for the Maryhill Line, a line which has suffered more than most.

In response the Transport Minister confirmed he will take a personal interest in performance on the Maryhill line, to ensure that ScotRail delivers. He advised the matter

will taken up with ScotRail when the Minister next speaks to them.

I am keen for constituents to get in touch about wider service improvements required, not just on the Maryhill line.

For instance following representations from constituents I recently had assurances from ScotRail about eliminating 'skipping' at Springburn station during peak time journeys, a practice whereby trains by-pass the station occasionally in order to make up time on a journey when running late.

## Council back to the future on schooling

Across the constituency in 2009 the City Council closed several primary schools. At the time I made strong representations to the council on behalf of parents saying they had got their sums wrong and there would not be enough school capacity.

It is no surprise therefore that the Council have just consulted on a new school for Maryhill on the site of the former North Kelvinside pitches.

## Working with parent councils

I work with Parent Councils across the constituency and I would welcome any invite to attend them.

Some recent matters I have sought to support Parent Councils on include Elmvale Primary Parent Council in relation to significant road safety issues, and work is ongoing in this area; St Mary's Primary Parent Council in relation to a campaign for a new outdoor sports pitch; and the Parent Councils at Ruchill's Benview campus over the city council's dire lack of disabled and buggy-friendly access to the school from Panmure Street.



However I have raised serious concerns over the lack of information available for the consultation, the lack of choice given over potential sites for the school, as well as ensuring that promises made to local sports organisation North Kelvin Sports, who use the NK pitches, are honoured by the City Council.

I will fight for the best deal for the local communities.



## Engaging with trade unions



I recently met constituents who are currently taking industrial action against Glasgow City Council over their concerns in relation to proposals to outsource the city's ICT services.

I share some of their concerns and I have corresponded with the Council and written to Audit Scotland following concerns that the plans may not reflect value for money for city tax payers.

I've also had the privilege of meeting the workers representatives at Springburn based City Building, which employs 2,000 people.

I discussed with their Joint Trade Union Convener's Group (JTUC) their views about the future of the organisation. The JTUC have been crucial in helping secure the long term future employment of the workforce.

The forthcoming Scottish budget, which I will be backing, will see schools in our constituency continue to benefit from the £750m Attainment Challenge Fund.

## IN PARLIAMENT

### Cross Party Group on Palliative Care

I have been elected as convener of the cross party group on Palliative Care in the Scottish Parliament.

I am very keen to ensure that we improve the support open to those coming towards the end of their life. I wish to see the successful implementation of the new Scottish Government strategic framework and its commitment that everyone who needs palliative care will have access to it.

On a personal level I was very grateful of the support and love provided when my own mother and father passed away in the last year. I want to do what I can to improve services for others.

I also want to help ensure that as a society we are more resilient when coping with the sensitive issues around death and dying.

### Bob becomes new convener of the Local Government and Communities Committee

It is a privilege to convene this committee. I am currently involved in scrutinising the Scottish Government budget in areas such as housing and local Government.

#### • Housing

I will be seeking to ensure that the Scottish Government's £3billion investment in affordable housing delivers the intended 50,000 affordable homes.

I will also be seeking to ensure that Glasgow City Council – who distribute the Scottish Government cash – ensures that local housing associations also benefit from that investment.

#### • Local Services

Our committee has identified significant amounts of Scottish Government cash that supports local services which is transferred from other budgets, including £250million for social care transferred from the NHS.

The draft Scottish Government budget increases this by another £107million. Much of that money is to ensure that social care staff are paid the living wage in Glasgow and across Scotland, as well as to deliver more care beds for those in need.

I will be seeking to ensure that money is well spent.
